The Men's Emmaus Experience offers you a unique opportunity to pray and reflect on your individual relationship with Jesus. APPLICATION PROCESS STARTING 8/27/2022

This extremely popular retreat is being hosted by St. Mark the Evangelist Parish but is available to all Catholic men on a first come first served basis without regard to Parish affiliation. The application process starts on August 27th and remains open for applications received by September 12th.

Materials for this retreat will be promulgated differently by Parishes. Many Parishes will have a sign-up weekend on August 27th and 28th. Others will distribute application materials on sign-up weekend but may not have sign up tables on that weekend.

To be processed, all applications need to be accompanied by a check **MADE PAYABLE TO ST. MARK THE EVANGELIST** for the full cost of the retreat. To maintain a totally neutral first come first served process, no applications will be considered accepted before August 27th.

PLEASE NOTE! DUE TO A STRICT "NO REFUND FOR ANY REASON" POLICY FROM THE LAKE YALE BAPTIST RETREAT CENTER, WE WILL NOT REFUND ANY APPLICATION MONEY AFTER SEPTEMBER 12TH.

Your completed application and payment will be deemed received if either occurs:

1. Envelope with fully completed application Forms and check is postmarked Aug 27th or later and received by Sep 12th.
2. Completed Forms and check are handed to an EMMAUS Team Member at your Parish during or after sign-up weekend. "Look for the men in white EMMAUS shirts".

All completed Applications received after Sep 12th will be returned and your name will be added to a wait list for the next scheduled EMMAUS.

Assumption of Risk and Waiver of Liability Relating to Coronavirus/COVID-19

The novel coronavirus (“COVID-19”) has been declared a worldwide pandemic by the World Health Organization. **COVID-19 is extremely contagious** and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.

The parish of St. Mark the Evangelist Roman Catholic Church ("St Mark the Evangelist' or the "Parish") has put in place preventative measures to reduce the spread of COVID-19; however, we **cannot guarantee** that you will not become infected with COVID-19. Further, **participation in Men's EMMAUS Leadership could increase** your risk of contracting COVID-19.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by participating in **Men's EMMAUS Leadership** at St. Mark the Evangelist in Summerfield, Florida and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 at St. Mark the Evangelist may result from the actions, omissions, or negligence of myself and others, including, but not limited to, School employees, volunteers, and program participants and their families.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I may experience or incur in connection with my participation in my parish ministry, activity, or event at St. Mark the Evangelist (“Claims”). On my behalf, I hereby release, covenant not to sue, discharge, and hold harmless St. Mark the Evangelist and the Diocese of Orlando, and all of their current, former, and future agents, representatives, religious and employees and related entities (collectively, “the Diocese”) of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of the Diocese, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after or participation in **Men's EMMAUS Leadership**.
